HoD report for ISO/IEC JTC 1/SC 25/WG 4 meeting in Tromsø, Norway 6/2000:

The US positions focused on the furtherance of NCITS peripheral interface standards were achieved. The WG 4 brief report that I presented and SC 25 accepted provides an overview of WG 4 status and meeting results along with the WG 4 resolutions that were also approved by SC 25 and the WG 4 action points.

Working Group 4 Brief Report:

SC 25/WG 4 had a very productive year and a very productive meeting in Tromsø from 12 June through 15 June covering all of the agenda items presented in SC 25 N 614A. During the past year twelve more of the original WG 4 projects and four of the former SC 26 projects resulted in standards text provided to the ITTF for publication as International Standards. At the moment there is a need to resolve which of these have been published and when the others will be published. Six standards were due for review in 2000 from the original list of SC 25 WG 4 projects and eleven from the former list of SC 26 projects. The recommended outcome of the reviews that were conducted are addressed by WG 4 resolutions.

After nearly a quarter century the convenorship of WG 4 is undergoing a change and WG 4 draws the attention of SC 25 especially to Resolutions 62 and 63.

At the conclusion of this meeting the projects of WG 4 include:

Seven projects which have completed CD/FCD balloting but with the FDIS not yet prepared.

Three FCD ballots to be issued.

One Fast Track ballot in process.

Six projects at the FDIS stage.

Thirty eight (twelve since last year) published or ready to be published International Standards from the original list of SC 25 projects and twenty

from the former list of SC 26 projects for a total of fifty eight standards prior to the processing of withdrawals.

Six standards to be confirmed.

One standard at the moment to be revised.

Four standards to be withdrawn and four drafts and/or projects to be withdrawn mainly due to progress with new versions.

Eight new projects currently expected before the next SC 25 meeting.

During this meeting WG 4 has recommended sixty-five Resolutions for approval by SC 25 and assigned eleven action points for WG 4 and the Secretariat.
