

ISO/IEC Status Report to T10

1. SC25 NWIP ballot for SCSI FCP-2 and SCSI SPI-4 , approved by T10/USA but failed in JTC1 due to not enough active participants. The recommended steps from here is to resubmit the NWIP with SC25 as the source. Two letter ballot motions in T10 corrected these items. Motions are provided below:

2. The IEEE Standards Association met on the subject of international representation for IEEE Computer Society Microprocessor SubCommittee. The IEEE is in the process of signing a Memorandum of Agreement with INCITS so they, the MSC, will become a TAG to ISO/IEC JTC1/SC25/WG4 along with T10 and T11. T10 and T11 will continue in their role but when this MoA is signed MSC will also be able to contribute and vote on their documents. This will separate T10 and T11 from IEEE MSC projects.

This topic was postponed on the JTC1 TAG Agenda because JTC1 TAG has merged with INCITS and new procedures for the combined group will need to be approved. In the mean time I have suggested that IEEE Computer Society MSC appoint a Liaison to T10/T11 SC25/WG4 TAG to deal with MSC issues until MSC can form their own TAG

3. The Convener of JTC1/SC25/WG4 Juergen Maergner has retired due to health reasons. There is a call for a new Convener SC25 N827.
