- 2. ISO/IEC FDIS SPC-2, 1.25.13.11.27: 14776-452, sent to SC25 for ballot, T10 needs to approve said document.
- 3. ISO/IEC IS 14776-115, 1.25.13.11.35 IT Small Computer System Interface (SCSI) Part 115: Parallel Interface-5 (SPI-5) has been approved as International Std and is ready for publication.
- 4. ISO/IEC FDIS SAS, 1.25.13.11.36: 14776-150: IT Small Computer System Interface (SCSI) -Part 150: Serial Attached SCSI (SAS). Was sent to SC25 for ballot. T10 has approved said document.
- 5. ISO/IEC FDIS MMC-2, 1.25.13.11.17: 14776-362 was approved a long time ago but ISO was waiting for changes made to resolve editing comments to be approved at T10. This was done and the document sent to SC25.
- 6. ISO/IEC FCD SAM-2, 1.25.13.11.19: 14776-412 FCD ballot closes 3/15/2004. SC25N 929, T10 has approved said document.
- 7. ISO/IEC NWIP SBP-3, 1.25.13.11.39: 14776-233A NWIP for Serial Bus Protocol -3, SBP-3, (T10/03-301r0) proposed project. has been sent for ballot. The US has voted YES.
- 8. ISO/IEC FCD, 1.25.13.11.13: SMC, 14776-351 has been approved as a new work item. I now need FCD text and PDF.
- 9. ISO/IEC 1.25.13.11.22: SES, 14776-371 has been approved as a new work item. I now need FCD text and PDF. Will use SES-2 instead.
- 10. ISO/IEC 1.25.13.11.37: SSM-2, 14776-132 has been approved as a new work item. I now need FCD text and PDF.
- 11. ISO/IEC 1.25.13.11.38: PIP, 14776-121 has been approved as a new work item. I now need FCD text and PDF.
- 12. AT7 (SATA). T13 would like to forward to SC25 via T10. If acceptable we need to approve a NWIP T10/04-91r0.
- 13. It was noted that ISO/IEC had made recommendations regarding a large number of international standards. The only recommendation directly affecting T10 is to remove ISO/IEC 14776-411:1999, Information technology -- Small Computer System Interface-3 -- Part 411: SCSI-3 Architecture Model (SCSI-3 SAM). Ralph Weber recommended that SAM not be removed since the international version of SAM-2 is not yet approved

## **MOTION 2:**

T10 recommend ISO/IEC 14776-411:1999, Information technology -- Small Computer System Interface-3 -- Part 411: SCSI-3 Architecture Model (SCSI-3 SAM) be confirmed and that the five questions be answered as follows:

Question 1: We are in favor of confirmation of the International Standard for a further period of five years.

Question 2: If the voting results show a need to revise the standard, we are prepared to participate in the development of the project. (YES)

Question 3: This ISO/IEC standard has been implemented as a national standard. (YES)

Question 4: The standard is implemented without change. (YES)

Question 5: The national standard is: INCITS.270:1996 [R2001]
