## Draft Minutes SCSI Media Changer (SMC) Working Group Ad Hoc Meeting T10/04-386r0 8 November 2004 6:00 PM – 7:00 PM CST

## 1. Introductions:

Michael Banther called the meeting to order at 6:13 PM CST. He thanked Crossroads for hosting the meeting.

2. Approval of the agenda:

Michael Banther discussed the order of the discussion items. No one requested a change.

Paul Suhler made a motion for acceptance of the agenda. Kevin Butt seconded the motion. In the absence of objections or abstentions, the group passed the motion unanimously.

## 4. INCITS Patent Policy

Michael Banther directed the group to a reading of the <u>T10 Short Summary</u> of the INCITS Patent Policy.

- 5. Discussion items:
  - a. Selection of Chair, Secretary, and Editor [Banther].

Michael Banther agreed to act as chair. Susan Gray agreed to act as secretary.

The position of editor remains unfilled. Michael Banther displayed the e-mail offer from Ralph Weber to edit the standard as a consultant (i.e., on a fee basis). Michael indicated that he will approach John Lohmeyer with a request to cancel the project unless one of three things happens before the conclusion of the January SMC-3 meeting:

- Someone volunteers to become SMC-3 editor;
- Someone indicates that they will become SMC-3 editor at some reasonable future point in time (e.g., within a few months); or
- Some company agrees to fund Ralph Weber to act as SMC-3 editor.

b. Goals of the working group (<u>04-279r0</u>) [Banther]

The group reviewed the five work items listed in the project proposal for SMC-3. We discussed whether the work provides a compelling case for securing resources from the participating companies. A significant sense that a compelling case does not exist became apparent. Michael Banther asked if additional compelling work items are known outside of those listed in the project proposal.

Erich Oetting and Rod Wideman described various vendor-specific element addressing mechanisms that currently exist. Rod asked if any ISV has expressed interest in the published list of SMC-3 work items. Michael Banther replied that none have and asked if any need exists to enhance the content of a SCSI Media Changer to support SMI-S. Rod responded that the SMI-S content largely overlaps that of SMC-x.

Erich Oetting pointed out that the model needs more information on how PAMR interacts with Import-Export elements. Rod Wideman agreed that this is an issue.

Susan Gray raised partitioning as an area of the model that could use some work.

Rod Wideman mentioned that no mechanism exists to group elements. Paul Suhler pointed out a specific case: that the addressing of removable magazines needs definition.

Paul Entzel reminded the group that SMC-2 had considered removing the attached media changer model.

Rod Wideman pointed out that virtualization has raised some functional-behavioural issues. Erich Oetting followed up with the possibility of specifying the ordering of tagged commands given the issue of shared hardware (e.g., the picker).

The group discussed whether we need to approach the SCSI Trade Association to seek engagement from the backup application independent software vendors.

Rod Wideman pointed out that two of the companies present supply backup applications. Some interest from these applications would advance the cause.

A consensus emerged that we need to engage the ISV's through their interest in ILM and use of multiple media types possibly through STA and possibly through SNIA.
