# 7. Discussion Items Group

7.1 Working List for ISV feedback (SMC/SSC/ADC/SPC) (05-315r2). Kevin Butt Kevin Butt presented the current state of work on the ISV feedback actions. The status of

ongoing work was discussed and changes were noted in the document. Kevin Butt to revise

and post 05-315r2 to note these updates. Noud Snelder agreed to own the effort to standardize existing conditions and events where ASC/Qs are listed with an "M" (those that apply to media changers). Kevin Butt agreed to contact Kevin Marks to ask if he would be willing to extend his proposal 05-158r2 from SSC to SMC.

Michael Banther inquired whether any feedback had been given to CA. Kevin Butt replied that some feedback had been given, and that CA had been informed that the work in progress would be reflected in document 05-315.

7.2 SMC-3 Read Element Multi-identifiers (05-153r1).

7.3 SPC-3 SPC-4 SES-2 SMC-3 Command requirements (05-074r1). Michael Banther

This item was deferred to the next meeting.

7.4 SMC-3 REQUEST DATA TRANSFER ELEMENT INQUIRY command (05-243r2).

Rod Wideman

Rod Wideman discussed the changes made from 05-243r1. The group discussed the value of this approach compared to the READ ELEMENT STATUS command or an approach using hierarchical LUNS. It was noted that this approach is uniquely suited for solving the problem of mapping DTE addresses to Target IDs and LUNS of drives, while providing the flexibility of using any chosen inquiry data for this purpose. This is not a generic tunneling mechanism, because the media changer can reasonably be expected to have more knowledge of the inquiry data of drives than of other data, and might in fact be synthesizing the inquiry data.

There was much discussion of how to differentiate the condition of an unsupported element address from the condition of a supported element address where the command failed for some reason. No sense key seemed appropriate for the latter case. The consensus was that a new ASCO should be used for the latter case.

Rod Wideman moved that 05-243r2 as modified be incorporated into SMC-3. Paul Entzel seconded the motion.

In discussion of that motion, Curtis Ballard suggested that his proposal in this area (06-046) should be considered before incorporating 05-243. Curtis Ballard motioned that Rod Wideman's motion be tabled until the next meeting. Halvard Eriksen seconded this motion. Curtis Ballard's motion passed unanimously. Rod Wideman's motion was tabled.

Rod Wideman will update 05-243r2 and post.

7.5 SMC-3 Clarification SEND VOLUME TAG command (05-414r1)

Noud Snelder

Noud Snelder discussed the changes made from 05-414r0. Paul Entzel questioned whether to obsolete this command. Rod Wideman noted that much of the functionality of this command does not apply to current media changers. Noud Snelder noted that there was nevertheless some useful functionality presented through the command. Curtis Ballard noted that this command was used by an application in order to move volumes by barcode. The group discussed the utility of a request to change the barcode on a medium.

Noud Snelder noted that the description of VOLUME SEQUENCE NUMBER, defined as a part of the volume tag, was extremely vague. Kevin Butt and Paul Entzel agreed to ask what

their companies do with this field. Noud Snelder will revise 05-414r1 and post based on the group discussion.
