

T11, Fibre Channel Interfaces October, 2006 Liaison Report

- TC T11 last met October 5, 2006.
48 representatives of 40 organizations attended. The number of members is 50.
New project SM-HBA-2 was announced.
FC-BB-3, FC-AE-ASM, FC-AL-2-Amd-2, and SNIA Multipath Management API published.
T11 took the requested actions of its TGs as described below.
- TG T11.2 - Fibre Channel Physical TG:
Membership is 39 organizations.
Projects in development include 10GFC Addendum, FC-MSQS, FC-MSM-2, FC-BaseT, FC-PI-3, and FC-PI-4.
A letter ballot was requested for FC-MSM-2.

Teleconferences were approved for FCSM-2, FC-BaseT, 8 Gb/s optical, 8 Gb/s electrical, and FC-PI-4.

Interim meetings were approved for FC-PI-4 and FC-BaseT.

- T11.3 - FC logical / protocol TG

Membership is 35 organizations.

A new project for FC-SB-3 Amendment 1 was approved by T11.3 (T11 will approve in December).

A letter ballot was requested for FC-FS-2 A1.

The IEEE Tutorial on OUI use by Fibre Channel was forwarded to IEEE.

Projects in the development phase include: FC-BaseT, FC-BB-4, FC-FS-2/Amd 1, FC-GS-6, FC-IFR, FC-SATA, FC-SCM, FC-SP-2, and FC-SW-5.

FC-LS and FC-AE-1553 are in comment resolution.

Teleconferences were authorized for FC-BaseT and FC-SATA.

- T11.5, storage network management TG Membership is 24 organizations.

FAIS-2, SM-HBA-2, and SNPing are in development.

FAIS was forwarded to INCITS for 1st Public Review and publication.

- ISO Actions

NWIPs were approved for FAIS, FC-BaseT, FC-BB-3, FC-DA, FC-FS-2, FC-GS-5, FC-MI-2, FC-PI-2, FC-SB-3, FC-SP, FC-SW-4, and SM-HBA.

Multi-path Management API was recommended for ISO fast-track.

- T11 TC and TG liaisons
