6. Old Business

The errata corrected, ANSI reviewed version of MMC-5 (rev 4) will begin its march to standardization during this month's T10 plenary.

David Walp asked for clarification on some issues.

1. START/STOP UNIT command description is missing what to do in the case that a "tray type" mechanism does not support a "Load" function. Fuji states that the command should be terminated with CHECK CONDITION status and sense shall be set to ILLEGAL REQUEST/INVALID FIELD IN CDB (5/24/00). To be fixed in MMC6. Katata-san suggests that (after the fix) both documents should document this command in the same way.

2. DVD+R and DVD+R DL profiles appear current when DVD+R DL media is present. Is this permitted? The DVD+R DL Feature description does not permit that behavior.

3. DVD+RW and DVD+R profiles are always present in a (particular) DVD-ROM drive. The profiles never become current. Is this permitted?

It is permitted, but it is silly. In MMC6 (and Fuji7), a recommendation must be included to avoid this behavior.

The T10 plenary must decide to either continue or release MMC as an ANSI standard. There was no objection to release MMC.

The T10 plenary must decide to either continue or release MMC3 as an ANSI standard. There was no objection to continue MMC3.

7. New Business

MMC6R00.PDF/DOC is available to the next editor.

A new MMC WG chair must be selected by the T10 chair. The T10 chair will choose according to recommendations from the MMC WG. The MMC6 editor(s) is to be selected by the new MMC WG chair.

No volunteers - yet. We will tell that T10 plenary that MMC WG meetings will be suspended until a decision is made. The MMC6 project is suspended until that time.
