Michael went over the changes. He stressed that those companies that have outstanding Action Items to report on definition of medium had better complete the action item.

## 5.2 Security-related items

## 5.2.1 SSC-3: Out of Band Encryption Key Management (07-361r4) [Ballard]

Dave Peterson raised a concern about using the physical device. Dave's concern seems to be in the terminology "physical device" instead of in the concept.

Dave Peterson does not want to have phrases as definitions (i.e., 3.1.61 and 3.1.62). These should be moved into a normative clause. Curtis agreed to this change.

4.2.22.3 Table y and table y+1 are insufficient to please Dave. There is much confusion about how an SSC device uses these and how these get set. There was a lot of discussion revolving around this point and Curtis took notes in the proposal.

Many additional edits were made.

Dave Peterson noted that we need to sweep SSC for Medium vs. Volume. Brought out by looking at the Physical device.

Curtis completed the review at 5:05 PM.

Kevin Butt moves that SSC-3: Out of Band Encryption Key Management (07-361r4) as revised be incorporated into SSC-3. Curtis Ballard seconded the motion.

Paul Suhler from Quantum stated he is uncomfortable voting on this without seeing all the changes in a completed document.

Dave Peterson is concerned about the Physical Device and that it needs to be used here. Kevin commented that the physical device was in SSC-3 prior to this proposal. Dave does not like that term "Physical Device". Dave asked how this relates to data encryption on more than one LUN. Will there be multiple physical devices? Kevin said in his interpretation, each LUN would be it's own instance of an SSC device and would therefore contain a physical device. Dave asked questions of assuming you have virtual tape drives, ....

Dave called the two week rule. Dave want's to see a document with all the changes uploaded two weeks prior to the next meeting in which this will be discussed.

Curtis thinks it will take one week to post the updates.

Dave Peterson made a comment that he does not like to have votes on major proposals like this on conference calls.
