8 Old business:

8.1 Automation encryption control ([08-029r1](#)) [Ballard]

Curtis Ballard led the group through a review of the changes to 08-029r0. The group provided various editorial suggestions. Noud Snelder pointed out an inconsistency in the wording of a data encryption parameters request sequence identifier. This led to an extensive discussion, which resulted in separating the wording of a data encryption parameters request sequence identifier from the fields that contain it. This change then resulted in rewording several places where the sequence identifiers are used.

We noted that the ABT bit and CABT bit descriptions were not consistent with respect to requiring the sequence identifiers to match. The consensus was to match the CABT description, such that ABT can be set to zero after processing of CABT set to one.

Curtis completed the review of all the comments that had been received and changes made.

Curtis Ballard made a motion to incorporate 08-029r1 as revised into ADC-3. Kevin Butt seconded the motion.

Discussion – Paul Suhler suggested that based on comments made during review, perhaps an additional review was warranted. Curtis stated that he would like to have the proposal approved in time for the new sense codes defined in it to be assigned for SPC4.

In the absence of objections and abstentions, the motion passed unanimously.
