Dear Ms. Barra:

The T10 technical committee reviewed the new INCITS Policy Regarding Document Access and Membership Benefits (RD-1, clause 3.2) at its March 13, 2008 meeting. The membership of T10 believes that this policy would significantly impair the committee's ability to perform its work and would significantly diminish the stature of T10 within the storage industry.

In place of the RD-1, clause 3.2, T10 believes its interests are best served by continuing its current practices:

Organizations interested in T10's work are strongly encouraged to obtain and maintain a voting membership as documented in INCITS RD-2, clause 4.2.3.1.4, in order to have a significant voice in the standards that T10 develops. The public is encouraged to voice technical concerns via participation in electronic communications to the committee and/or non-voting participation in T10 meetings. However, only T10 voting members are permitted to make motions or to vote.

The public, including liaison organizations, are allowed access through the committee web site to the T10 projects list, membership list, press releases, meeting schedule, meeting notices, draft agendas, committee proposals, and meeting minutes.

This policy encourages the timeliest development of draft standards with minimal iterations of public review. Open access to committee documents avoids any appearance of impropriety and avoids burdening committee officers with fulfilling requests for documentation for patent or other legal reasons.

Accordingly, T10 is requesting a waiver from clause 3.2 of the RD-1 as documented under item 10.4 of the T10 minutes (T10/08-133r0). For your convenience, this item is reproduced here:

"John Lohmeyer presented INCITS in080213 (T10/08-115r0), a policy recently adopted by INCITS.

Bob Griswold moved and Kevin Marks seconded that the T10 Technical Committee approve T10/08-143r0, a request for a waiver from INCITS RD-1 clause 3.2.

The motion passed 29:0:0:8=37 by a roll call vote." (The details of the roll call vote are included below.)

Please place this formal request for a waiver on the next Executive Board agenda.
