Dear Dr. von Pattay,

Thank you for correcting the IEC 60027 reference. I have noted this for future SPC-x standardization work.

I have included the front matter, Clause 1, and Clause 2 changes in my files ... with one exception:

```
-- ISO/IEC 14776-381, Information technology - Small computer system
-- interface (SCSI) - Part 381: Optical memory card device commands (OMC)
```

In these case, the acronym needs to be as shown in my source files. Specifically, OMC needs to be OCRW for consistency with several tables in the document (e.g., Table 28).

I have not included the changes shown in defines071119.fm. These changes are not acceptable because they substantially reword the glossary content. I am pleased to note that these changes do not appear in the isoiec14776-453_2008-11-24.pdf file attached to your e-mail message.
