 - attend two out of three successive meetings, in which case the membership shall be terminated if not represented at the next meeting; or
 - return ballots from two successive mailings, in which case the membership shall be terminated if the next ballot is not returned.

(b) The voting membership will be canceled by the X3 Secretariat for failure to pay appropriate service fees within the time specified by the X3 Secretariat.
