## ISO/IEC Style Manual Adopted By Institute

ANSI has published the eighth edition of its "Style Manual for Preparation of Proposed American National Standards." To facilitate the international adoption of American National Standards, the new manual reflects the style specifications contained in the International Organization for Standardization (ISO) and the International Electrotechnical Commission (IEC) "Directives Part 3, Drafting and Presentation of International Standards."

These new style specifications are being used by the Institute for the standards ANSI publishes. The Institute recommends that standards developers which publish ANSI-approved standards follow this manual wherever possible in order to help create a consistent set of American National Standards. Consistency will enhance the usefulness of the standards in national and international applications.

The current edition of the manual is divided into two chapters. The first chapter contains written specifications regarding content, style, publication procedures, and ANSI policies. The second chapter contains sample standard elements that illustrate the written specifications. The chapters are cross referenced.

"Guidelines for Submitting Proposed American National Standards in an Electronic Format," a companion document published with the style manual, provides a description of the ANSI publishing system, a list of accepted and preferred file formats, preferred file preparation procedures and other relevant information. It will be particularly useful to technical contacts who have chosen to provide an electronic manuscript to ANSI for publication.
