Results of Meeting

1. Opening Remarks

John Lohmeyer, the Chair, called the meeting to order at 9:00 a.m., Monday October 12, 1992. He thanked Buzz Rigsbee of Boeing Computer Services for hosting the meeting.

John said that the X3 Secretariat prefers receiving membership changes on the "X3 Subgroup Membership Forms" which were available on the document table. He said that people should use the X3 forms to insure the X3 Secretariat has the latest membership information. The forms should be mailed to the X3 Secretariat with a copy to John Lohmeyer.

As is customary, the people attending introduced themselves. A copy of the attendance list was circulated for attendance and corrections. Copies of the draft agenda and the recent document register were made available to those attending. Information on X3T9.2 and Mailing Subscription Forms were made available.

2. Approval of Agenda

The draft agenda was approved with the following additions:

- 10.8 Procedure for Funding X3T9.2 Technical Editors [Lohmeyer]
- 10.9 Cache Control Revisited
- 10.10 How should SCSI address RAID environments?

3. Attendance and Membership

The membership requirements were reviewed. X3 rules permit one vote per organization. An individual from a new organization must attend two out of three consecutive plenary meetings. He/she may apply for voting membership the second meeting via a letter to the Chair of X3T9.2. The individual may vote at the second plenary meeting. Working group meetings do not count toward attendance requirements.

John Lohmeyer noted that the following changes in the voting membership had occurred since the last meeting: BusTek changed their company name to BusLogic; Soon Ahm Kang is the new principal member and John T. Aguilar is the new alternate member of Control Data Systems, Inc. (formerly Control Data Corp.).

Chuck Duquette and Dennis Mellinger of U.S. Design, Alan Ebright of Toshiba America, Janet Schank of Central Data, and Shahnad Nadershahi of Amdahl became voting members at the October meeting. Gary Peterson of Data General and Steve Finch of Silicon Systems having met the attendance requirements were re-instated as voting members.

With the termination of two organizations for nonattendance (see 3.1), the X3T9.2 voting membership is now at 65 organizations up from 61 at the last meeting. Enclosure (1) is the list of the people present at the meeting and enclosure (2) is the current X3T9.2 membership list.

3.1 Roll Call of Members in Jeopardy

The Chair said he had sent jeopardy letters to 15 people from 5 organizations: Advanced Micro Devices, Cirrus Logic Inc., Control Data Systems, Inc., National Semiconductor, and Tandem. The letters said that these organizations had failed to attend two of the last three plenary meetings and that their membership would be terminated unless they attended this meeting. The letters also informed these people of the committee's ability to retain their membership under special circumstances in spite of their failure to attend.

The Chair had received a phone call from Soon Ahm Kang, the principal member from Control Data Systems, Inc. pointing out that he had attended the Seattle meeting, but had failed to sign the attendance sheet. Therefore, the Control Data Systems membership was not in jeopardy.

Representatives were present from all of other organizations except:

Advanced Micro Devices and Tandem. The P and A members from these organizations were changed to observer status.

The Chair also noted that membership can be terminated for not returning letter ballots. The rules are slightly different in that the chair must send warning letters to those organizations that fail to return letter ballots from two successive mailings. If the organization fails to return the next (third) letter ballot, then their membership is terminated.

4. Approval of Minutes - August Meeting Bellevue, WA (92-166 R0)

The minutes were approved as written.

5. Document Distribution

John Lohmeyer said that the committee mailing had gone out a bit later than usual, but he had still received his more than two weeks prior to the meeting. Members who have any problems with their mailing subscription should deal directly with Katrina Gray at (202) 626-5741.

Larry Lamers requested that all documents for the next mailing must be sent so as to be received by noon on Thursday, November 5, 1992. Documents received after this date will go into a subsequent mailing.

Larry Lamers reminded the committee of the requirements for document submission to be included in the committee mailing. Since X3T9.2 meets its CBEMA document archiving requirements by including CBEMA on the mailing list, documents included in the mailing must be suitable for microfilming. This means that high-quality, single-sided originals with adequate margins and proper identification must be submitted. Document X3T9.2/92-84 R1 contains the list of requirements for submissions.

6. Liaison Reports and Call for Patents**6.1 ISO [Milligan]**

Gene Milligan, the X3T9 International Representative, gave an oral report and later provided an electronic report to X3T9:

Inquiries were received concerning PCMCIA and future ISO/IEC work plans. X3T9/IR92015 was sent to Schwandt clarifying PCMCIA and its relationship to X3T9 standards work. The letter also reiterated the X3T9 strategy relative to synchronization of ANSI and ISO/IEC standards. It also mentioned the proposals that have already been submitted since the Milan meeting: FDDI Station Management (SMT) Rev 7.2; Fibre Channel (FC) Physical and Signaling Interface (PH) Rev 2.2; High-Performance Parallel Interface (HIPPI) Framing Protocol (FP); High-Performance Parallel Interface (HIPPI) Encapsulation of ISO 8802-2 Logical Link Control Protocol Data Units (LE); and High-Performance Parallel Interface (HIPPI) Physical Switch Control (SC).

New Project proposals have been prepared for the ATA and CAM dpANS as contributions for International Standards. The IR has not yet received the appropriate electronic text from X3T9.3 for the IPI-3 Disk and Tape projects.

The IR submitted X3T9/IR92016 to Kate McMillan, X3 Secretariat, for resolution of the Streaming Cartridge Tape

Device Interface ISO/IEC 9317 stalemate. It requested that since there has not been any opposition to the standard expressed, it would be appropriate to first seek an editor from other member bodies prior to actually withdrawing the DIS and international project. Consequently it requested that the X3 Secretariat take the necessary steps to request that the SC 25 Secretariat issue a call for a DIS 9317 project editor and that if the call does not result in an appropriate volunteer that the project be withdrawn. It stated that it should also be clear that the U.S. member body does not expect to volunteer a project editor.

AOW has started a project to develop an amended FDDI ISP which changes from an informative SMT Rev 6.2 to a normative SMT Rev 7.2. Their completion target is 12/92 but they also require that SMT reach the DIS stage. These two goals are not congruent.

It had been alleged that the SC 25 work on a Planning and Installation Guide for Customer Premises Cabling to Support Attachment of ISO 8802-5 Token Ring Stations was in conflict IEEE P802.5k. R.L. Pritchard of the IEEE Standards Department concluded that P802.5k was an obsolete draft of the ISO/IEC work and not conflicting.

A call was issued for experts in Command Control and Communications of Commercial Buildings for an SC 25 ad hoc. The SC 25 Secretariat prefers that only one expert should be named and Ron Clapman has volunteered.

JTC 1 has passed a resolution to form a special working group on Conformity Assessment. The US offer to provide the Secretariat and convener was accepted.

6.2 IT8 [Lohmeyer]

John Lohmeyer had nothing new to report.

6.3 Fibre Channel [Allan]

Dal Allan reported.

The Fibre Channel Physical document is in public review. The Enhanced physical work continues and includes hunt groups and improved bandwidth. There has been a series of debates on the mechanism of control. The Internet protocol is moving forward rapidly and the IBM ESCON protocol is making progress.

The fibre channel folks are curious as to what X3T9.2 is doing on the serial protocol issues.

6.4 Small Form Factor Industry Group [Allan]

Dal Allan reported orally and provided the following written report:

Form Factor patents issue - the HP 1.3 device is of concern - a letter from HP states that HP does not believe that form factor is a patentable issue, but not a blanket approval for reverse engineering.

Letter from Patent Office - Industry group to educated PO on form factor. There was a decision on a patent application from Conner by PO that form factor is not significant.

Another patent on mounting brackets.

2 versions of 69 pin ATA in pending approval within SFF. Cautious approval to continue SFF and restructuring.

Unitized connector proposal - will be handled in SFF.

6.5 IEEE P1394 [Smyers]

Dennis Pak reported.

The intent is to finalized the input for the P1394 document by December '92. A final document for letter ballot is expected in January '93. The DS encoding has been adopted (8B10B has been dropped). The current length is 4.5 meters at 6 hops maximum. Configuration management is expected to be added in January '93. A letter ballot is forthcoming on the proposal to switch genders on the connector.

6.6 SSA Status [Scheible]

Larry Lamers reported. A project proposal has been developed to do the SSA project within a new task group. The next SSA meeting is scheduled is for October 26, 1992. Contact John Scheible for details at TEL: 408-284-7719 or E-MAIL: scheible@sjevm5.vnet.ibm.com.

6.7 IEEE P1285 Status

Dennis Pak reported. See document X3T9.2/92-204 for minutes of the "grass roots" meeting.

A co-located P1285 meeting is scheduled for Thursday, Nov 12, 1992 in Sunnyvale, CA. The next P1285 meeting is scheduled for Dec 11, 1992. The next grass roots meeting is scheduled for the week of Jan 25, 1993.

6.8 Call for Patents

This is a regular agenda item to identify any potential patent issues with developing standards. Patents that may be related to various X3T9.2 projects are a Conner Peripherals patent on power management, a Maxtor patent on spindle synchronization, and an AMD patent (5,113,098) on a glitch filter for SCSI signals.

A document is available from ANSI, "Procedures for the Development and Coordination of American National Standards", at no charge. The last page contains the ANSI patent policy.

8. Working Group and/or Project Status Reports

8.1 SCSI General Working Group (X3T9.2/92-194) [Lamers]

Larry Lamers reported on the last working group meeting. See 92-194 for details.

8.2 SCSI-2 Status [Lamers]

The final editing of the SCSI-2 document is proceeding and is expected to be completed by the end of October. The revised document will be sent through proper channels to the ISO editor for approval.

8.3 SCSI Common Access Method (CAM)

CAM is in its public review period that closes January 1, 1993.

8.4 AT Attachment Status (ATA)

The current revision of this document is 3.1. As a result of the Toronto working group, Dal Allan is preparing a revision 3.2.

8.5 SCSI-3 Architecture Model (SAM) Status [Monia]

Charles Monia reported that the input from the working group has been incorporated in the SAM document.

8.6 SCSI-3 Parallel Interface (SPI) Status [Lamers]

Larry Lamers reported that revision 7 was in the last mailing; revision 8 is under development. An SPI working group is scheduled for Wednesday. There are some difficulties with the way clause 10 is written; it needs to be re-constructed as services and indicators.

8.7 SCSI-3 Interlocked Protocol (SIP) Status [Lamers]

No change.

8.8 SCSI-3 Generic Packetized Protocol (GPP) Status [Stephens]

Gary Stephens reported that he rearranged pad bytes to sub-elements on four-byte boundaries. A revision 2 will be provided for the January mailing.

8.9 SCSI-3 Serial Bus Protocol (SBP) Status [Gardner]

At the last working group the Apple-DEC-IBM contingent agreed to agree on a serial protocol for use on P1394. Further information was promised for the plenary meeting (see agenda item 9.9 and document 92-199).

8.10 SCSI-3 Fiber Channel Protocol (FCP) Status [Snively]

Robert Snively reported that the FCP document was in the last mailing. It has engendered feedback and this will be incorporated in the next revision.

8.11 SCSI-3 Command Set (SCS) Status [Lamers, Stephens]

No activity.

8.12 Directly-Addressable Device Interface (DADI) [Lohmeyer]

John Lohmeyer reported that X3T9 had sent a letter responding to the HP No vote on approval of the DADI project proposal. A project number should be issued soon.

8.13 ATA Extensions [Lohmeyer]

The ATA Extensions project has been approved and given project number 948-D.

9. Old Business**9.1 Enhancement of Sequential Access for Medium Changers (92-006R1) [Stephens]**

Several medium changer commands are proposed for inclusion in the SCSI-3 Primary Commands. These functions are viewed as generic and useful to a large number of device types and should not require implementation of a second device type to be able to use those functions. The PREVENT ALLOW MEDIUM REMOVAL command is also proposed for inclusion in the primary commands.

Gary Stephens moved and Jeff Stai seconded that 92-006R1 be included in the SCSI-3 Primary Commands document. The motion carried 25:2:0.

George Penokie stated that the M-Changer bit should be byte 6 bit 6 of the INQUIRY data. The document should be revised to include this information.

9.2 Unitized Connector (92-139R1) for SCSI-3 [Cornaby]

The consensus was that since work on the unitized connector is being done in the SFF committee that X3T9.2 wait to see if a consensus develops in SFF.

9.3 PR Comments on BSR X3.221-199x, ATA (AT Attachment)

John Lohmeyer presented six draft response letters (three for registered comments and three for unregistered comments; Gene Milligan had indicated that he did not wish a response to his informal comment which was accepted). A letter ballot will be conducted on approving the response letters.

Dal Allan, the project editor, requested guidance on which items should be included in ATA and which should be deferred to ATA Enhanced. The corrections for DMA transfers and logical block addressing were accepted for inclusion in the ATA document without objection. The 44-pin SFF connector proposal, which uses a 50-pin 2 mm connector to provide additional keying and four vendor-specific pins was controversial.

Gene Milligan moved and Dal Allan seconded that the 44-pin SFF connector definition be included in the ATA document. Larry Lamers requested a role call vote. The chair ruled that this motion only required a simple majority. The voting results were:

The motion carried 18:7:0:38.

It was agreed that the rest/resume functions and the download microcode commands should be deferred to the ATA Extensions project.

9.4 SCSI-3 Queuing Issues (92-141) [Penokie]

George Penokie moved and Charles Monia seconded that 92-141R5 be accepted for inclusion in SAM and SIP. The motion passed 26:0. [Special thanks are in order for George Penokie's persistance in developing the queuing model.]

9.5 Synchronization Status and Errors (92-130R1) [DeKoning]

No activity.

9.6 Proposal to add a disconnect unconditionally after command phase (92-133) [Smyers]

There was objection to tying the disconnect to specific commands. There was general agreement to remove the implementors note. A wording change was suggested to "shall not allow a data transfer phase on an initial connection." Larry Lamers suggested that a bit should be in the control byte for providing disconnect information. At this point the consensus was to do another revision on the proposal to incorporate some to these ideas.

9.7 ASC/ASCD for Power-On Reset [Houlder] (92-162R1)

The revision 1 document was in the mailing. Gerry Houlder moved and Norm Harris seconded that 92-162R1 be accepted for inclusion in SCSI-3.

The motion carried 25:0:0.

9.8 SCSI-3 Architecture Model Issues [Monia]

Charles Monia recapped the items from the working group on addressing. See 92-194 for details.

The discussion turned to handling an AEN. The question of establishing an initiator ID was raised. It was suggested that an association header may be needed. Then the question was how to discover the Initiator ID before an I/O process has occurred. In AEN, the temporary target is always selected by the temporary initiator and the who-to-send-the-AEN-to needs be provided as a priori information. The target is not able to deduce the initiators from the I/O processes.

Bob Snively stated that his definition of TARGET ID is the name of an address of a particular physical node and LUN ID is the process/routine behind it is LUN.

Gary Stephens then requested the addition of a non-transport specific initiator handle of at least 96-bits in size. The consensus was that a proposal on paper is needed to continue this discussion.

The subject of target routines then came up with the proposal to remove them from SCSI-3. Gene Milligan moved and Ed Gardner seconded that Target Routines be removed from SCSI-3 and all the associated documents and the existing functionality of Target Routines be provided by enhancements through logical unit addressing.

Dal Allan moved and George Penokie seconded that the question be divided by document. The motion passed 21:4.

The first motion was that Target Routines be removed from the SCSI-3 Architecture Model and the existing functionality of Target Routines be provided through logical unit addressing. The motion passed

21:4.

The second motion is that Target Routines be removed from the SCSI-3 Protocol documents and the existing functionality of Target Routines be provided through logical unit addressing.

Dal Allan moved and John Lohmeyer seconded to defer consideration until the December 1992 plenary. The motion failed 9:12.

The main (second) motion passed 13:8.

9.9 Serial Protocol Issues [Gardner, Smyers, et al]

Gerry Marazas presented an overview of a serial protocol for use on P1394. The material is in a fairly primitive state and needs substantial work, however the essential elements are there.

Jeff Stai moved and George Penokie seconded that 92-199 be accepted as the proposed working draft for the SBP project. The motion passed 29:0:0.

Gerry Marazas requested a straw poll on whether or not the sense offset be maintained as an unsigned 8-bit value. The overwhelming majority opposed the use of sense offset.

The next straw poll found a majority in favor of having a fully arbitrary relationship between command blocks and sense buffers.

The next straw poll found a majority opposed to SBP postulating a one-to-one relationship between command blocks and sense buffers.

The discussion jumped into queuing, linked commands, and how SBP deals with them. Ed Gardner express a opinion that linked commands are a needless complexity and sees no justification for the current proposal to support them. The discussion on the interaction of queuing and SBP was lengthy.

Chained commands, a feature of the proposed SBP, in a multi-initiator environment obviates the ORDERED queue tag. If the initiator model of the task set is followed and no ORDERED chained commands are used the present queuing model works. Support of isochronous services could disrupt ORDERED commands. Chained commands are in primarily to support isochronous; and since the expert on isochronous was not present the discussion was deferred.

9.10 SFF Submission for SPI Annex (92-170) [Allan]

Dal Allan presented the proposal from SFF for an annex defining 50- and 68-pin signal assignments for internal connectors. This document will be included in the next mailing for a plenary vote.

The intention is for the EIA CE2.0 committee to deal with the connector dimension specification and location of the connector within a form factor.

9.11 Active Termination Requirements [Wallace]

Dean Wallace made a brief presentation on active termination for 10 Megatransfers/sec. Active negation drivers are not always needed, particularly near the terminators. Active negation drivers are important when the device is in the middle of the bus. Good receivers are a critical part of a system that functions properly.

10. New Business**10.1 Letter Ballot results on Response to SCSI-2 Public Review Comment (92-175)**

John Lohmeyer presented the results of the letter ballot (X3T9.2/92-175) on approving the draft response (X3T9.2/92-147) to the public review comment (X3T9.2/92-146) received from U.S. Design. The response was approved 52-0-0-9 (Advanced Micro Devices, Berk-Tek, Bull/Zenith, Burndy, Connector Industry Consulting Group, DDK Electronics, Honda Connector, Micropolis, and Texas Instruments). John Lohmeyer accepted an action item to request X3T9 to approve the response.

10.7 Density Code Addition for Stream Devices (92-164R1) [Williams]

The September working group recommended that this proposal be accepted for SCSI-3. Jeff Williams moved and Skip Jones seconded that 92-164R1 be accepted for SCSI-3. The motion passed: 21:0:0.

10.8 Procedure for Funding X3T9.2 Technical Editors [Lohmeyer]

One can use the number of segments field to deal with larger segments, however their size cannot be reported. The consensus was that the document probably reflects the decisions made. Since there are some products that have implemented the proposal, no one was too excited about "fixing" the problem. [Chair's note: I added this item to the working group agenda to review the issue in a bit more detail.]

10.10 How should SCSI address RAID environments?

George Penokie stated that a number of issues exist in implementing SCSI in RAID environments. George prefers a study group approach that may or may not lead to the development of a standard. An initial meeting is scheduled for Monday, November 9, 1992 in Sunnyvale from 5:00pm to 8:00pm.
