# 6.1 Domain Validation Testing Methods (01-033) [Gibbons]

Terry Gibbons reviewed 01-033r2 and made further changes that the group recommended. He planned to send these changes to Ron for inclusion in Rev 5 of SDV.

## 6.2 SDV working draft review [Roberts]

Ron led the review of the latest document, SDV rev 04.

# 6.3 Definition of margin fields in mode pages [Ham]

After considerable discussion, four parameters were defined for the driver. Driver asymmetry, Driver pre comp, Driver strength, and slew rate.

No parameters have so far been defined for receiver parameters.

## 6.4 Definition of values in margin fields [Ham]

After much discussion a list of field value were agreed where the field values indicate absolute conditions (i.e. not depending on previous history) centered around the value of the parameters as shipped by the supplier. This is based on the so-called 2's complement scheme where there are 7 values above the shipped parameter value and 8 values below the shipped parameter value.

Motion Aloisi/Evans that SDV recommend to the parallel SCSI working group that the material in SDV rev 5 contained in subclause 5.3.3.1 be incorporated into subclause 18.1.4.1 and Annex G of SPI-4 rev 3 in place of material presently in place. Bill Ham to do the action item.

Motion passes unanimously.
