Unanimous approval by the PHY group to combine Xr/Xt and Ir/It as Xr/Xt and convert Dr/Dt to Ir/It name for internal connector interoperability points. This will avoid the confusion of Dr/Dt as the drive connector rather than the internal connector. Also determined that the zero-length test load would make a suitable system level test load at the

target connection to verify the system meets internal receive requirements. Reference should be added in the appropriate subsections of 5.3 and 5.4.
