Curtis Ballard

Curtis Ballard presented the changes to his proposal from the previous revision. The group discussed whether limiting the number of volume type and qualifier combinations to 255 was too limiting, and agreed that Table y+3 should be changed to allow for a 2-byte descriptor count field.

Paul Entzel noted that the new editorial standard is to avoid "header" tables and instead use "parameter data" tables which show the header and the space for descriptors. Editorial changes were suggested for table y+5.

The group discussed the term "universal" in table y+1, and concluded that the term "All Qualifiers" was more self-descriptive. The group had further spirited discussion of "form factor".

7.5 SMC-3: Diagnostic and statistics log pages for SMC (06-182r1)

Kevin Marks

Kevin Marks presented the changes to his proposal from the previous revision. The group suggested replacing the terms "hard" and "soft" error with "unrecovered" and "recovered". The group discussed the practicality of counting barcode errors, and concluded that the level of detail desired is not practical for many commercial readers.

Rod Wideman emphasized the importance of being able to reset the counters in this proposal. It was noted that deferred errors don't occur for SMC commands, as they don't use the immediate bit.

Kevin Marks will split 06-182r1 into two documents for separate consideration.

The group discussed the practicality of this proposal, as it seemed quite complex for low-end devices. Rod Wideman noted that he "loved tape alert". Participants representing automation groups wills inquire about the difficulty of this proposal with their automation group.

8. New Business Group

8.1 Discuss volumes and addresses in SMC Model clause (5.2.1) Greg Wheeless

Greg Wheeless asked the group's opinion about the clarity of this model clause. The group consensus was that there was not a large problem, merely small issues with wording: the word

"storage" is problematic, an element "may contain" a volume, a volume should be "in" an element, "at" an element address.
