##### 5.2.1 Keyless Copy of Encrypted Data (06-462r2) [Butt]

This was discussed. Most of the time was spent covering the new flowchart of the Keyless copy operation. Highlights of the feedback were:

- a. It is not clear when a box is talking about a the source device server or the destination device server. Please specifically indicate which one
- b. Please see about defining a term to use for the source and for the destination. Keep in mind that the destination may not be a device server. Suggestions included using Keyless Copy source LUN and Keyless Copy destination LUN.
- c. There is confusion because there is no “why” described. Consider adding some “why”s. e.g. Why does an application client do this or that.
- d. A point of confusion is the decision box that talks about EXTERNAL mode when reading in RAW mode. This would best be handled by defining requirements the devices server places on things while in raw mode. Perhaps stating that in order to read in RAW decryption mode the key-associated data descriptors must match the key-associated data descriptors taht would be required if the device server were placed in EXTERNAL encryption mode
- e. There was a lot of discussion on how this chart is trying to include everything - application client, source device server, and target device server. One suggestion was made to use three different flow charts, one for each entity. Another to use a sequecing diagram. Yet another to make an informative flowchart for the application client with normative state diagrams for the source and destination device servers. -- This seemed to be the path most desired to be followed.
