Michael Banther introduced the proposal and explained its purpose and extent. It adds a list of commands that a local ADC device server may support without passing them through to the remote ADC device server.

Kevin Butt asked for and received clarification of the location for the proposed text.

Rod Wideman suggested alternative text. Michael Banther agreed to this text change.

Michael Banther made a motion to incorporate <u>07-125r0</u> as revised into ADC-2. Paul Entzel seconded the motion. In the absence of objections or abstentions, the group approved the motion unanimously.

# 6.3 6.3 ADC-2 Primary port index (<u>07-165r0</u>) [Entzel]

Paul Entzel introduced the proposal and explained its purpose and extent. It resolves three ADC-2 letter ballot comments, Dell-118, Dell-120, and HPQ-248. All apply to the Relative Target Port. Paul walked the group through the proposal.

Rod Wideman raised a point about the use of the phrases, 'primary port index' versus 'DT device primary port index.' Rod and Paul Entzel discussed which phrase to use and agreed on 'primary port index.' Rod also asked about some existing text that had been moved and which is not well formulated. He, Paul Entzel, and Michael Banther debated the possibilities and decided to leave the offending text alone until ADC-3.

Paul Entzel made a motion to incorporate <u>07-165r0</u> as revised into ADC-2. Kevin Butt seconded the motion. In the absence of objections or abstentions, the group approved the motion unanimously.
