Gideon asked for an additional note that states "Warning to the user that even the layman will understand that even if he sets the no copy bit the media is not bullet-proof."

Discussion surrounded the fact that nobody knows how to do this without saying you cannot trust that any encrypted media has not been copied by raw copy methods.

[Paul Entzel] The point was brought up that if we state this is not cryptographically secure then we must do the same for all areas in the standard where things are not cryptographically secure.

The point was also brought up that a user will need to reference P1619.1 also to ensure that a tape drive is secure - assuming the tape drive claims compliance to P1619.1.

One of the changes to acronyms was missed in this revision and Paul stated he would change it.

Gideon wants to qualify statements about disabling reads by adding "in device servers compliant with this standard". Discussion was that everything we state implies "in device servers compliant with this standard".

Paul Entzel moved that Additional controls for keyless copy (07-016r2) be included in SSC-3. Chris Williams seconded. The motion passed on a 4:0:1 vote.
