Others wish to present this, especially if you have some virtual media and some physical media and the application needs to know that the virtual media cannot be exported. Then there is that only virtual media can be loaded in virtual drives.

7.7 SMC-3 Processed commands during not ready state (07-060r2) [Snelder]

Curtis questioned the definition of Not Ready. Kevin Butt agreed that this definition may not be accurate. There may be cases where this definition fails.

The table is leveraging requirements on the SMC device server to return CC when ANY element is not ready. This is becoming more restrictive.

Rod Wideman commented via instant messaging with Paul Entzel that since the intent of this table is to help ADC this belongs in ADC.

Noud withdrew this proposal.
