Element Static Information

Kevin asked why the Element Static page was not a new Inquiry vital product page. Curtis pointed out that this covers many elements - perhaps thousands and that does not seem to fit the Inquiry command. Inquiry pages seem to be for top level requirements not for elements. People are used to using Read Element Status so this is similar to that.

The exp and cod bits show what upgrades are available for upgrade, either by buying and installing a new module or enabled by a license.

The cnxp bit specifies that the volume cannot be exported. It really talkes to virtual devices. Kevin asked if this mechanism is really needed or is this just standards lets try to cover everything possible? We don't want to create complexity for something that won't be used.

Curtis said he has heard of people talking about mixed devices (i.e., real and virtual).

Erich asked if there was need for a model clause to be added related to reconfiguring the personality of an element.

Michael asked Kevin to bring a companion to 06-138 into SMC-3 once it has been accepted in SSC-3.

The question was asked if we should define activation conditions for specific flags. Roger Cummings stated that they have made recommendations that have not been included (e.g., 05-339r0). Roger said it would be very useful to do so. Michael thinks activated when this event occurs. Roger would prefer this event and only this event. Michael doesn't want exclusive. Roger views SMC TapeAlerts are less useful than SSC TapeAlerts. Roger wants to check with his company to see if SMC TapeAlerts are useful enough to keep.
