#### 6. Old Business

6.1 INQUIRY response data format in MMC-4 and MMC-5 are set to 0011b. All versions of SPC declare that 0011b is reserved. MtFuji7 is consistent with SPC.

The editor of SPC-4 will accept a change to SPC-4 that permits 0011b in MMC-6. However, SPC-4 may not be a standard until after MMC-6 is completed.

Action Item for the MMC WG membership:

Decide: Do we return to 0010b as in MMC, MMC-2, and MMC-3 or do we make MMC-6 the same as MMC-4 and MMC-5?

### 6.2 TCG Optical Security Subsystem Class

Status: The specification was accepted by the TCG Storage Working Group in April. It was accepted – with changes for interchange – in June.

It is now under review by the TCG Board of Directors for approval to be made public. The BOD should have a decision before the September MMC WG meeting.

7.1 Proposals and Questions

BDA proposal from Katata-san

BD\_cmds\_r110\_july\_a.pdf was distributed with command and behavior changes from the BDA. Katata-san described each change. These will be put into MMC-6.

## GESN clarification requested by Dave Walp

Should manual load report Device Busy events same as START STOP UNIT with Immed=1? Some drives have been found that do this, but MMC-5 only requires the behavior from command execution.

Proposal: Define the behavior as optional in MMC-6.

There were no immediate objections from WG members, but most wish to study the proposal before accepting it. To be revisited at next MMC WG meeting.

Question to Microsoft: Suppose the behavior is present. Is there value in knowing that the capability exists? i.e. a bit in the Removable Media Feature Descriptor?

## 7.2 Applicability of HD DVD media types

MtFuji7 contains information about HD DVD-ROM, HD DVD-RAM, HD DVD-R SL and DL, HD DVD-RW SL and DL. It is possible that some of these disc types may never be made. Consequently, drives that could handle those disc types would not be made. We need to decide if any of this is true. If any is true, then which disc types are affected? Finally, should any be excluded from MMC-6?

Action item for chair: Contact Toshiba representatives about this question. Report at next MMC WG meeting.

## 7.3 Begin review of MMC-6 Rev 2

Clause 1 is small and not changed. We shall read it and check for potential changes. Reviewed and found OK.

Clause 2 has a new reference listed. We should check for completeness.

Action item for Dave Walp: Is it OK to leave MRW in MMC-6? Should it be labeled Legacy?

Clause 3 has a few new abbreviations. We should check for completeness.

Clause 4 still requires work. Skip clause 4 this meeting.
