## Results of Meeting

### 1. Opening Remarks

John Lohmeyer, the T10 Chair, called the meeting to order at 1:30 p.m., Thursday September 11, 2008. He thanked LSI for hosting the meeting.

John said that INCITS subgroup membership forms and the T10 document subscription forms are available on the meeting web site. He said that people should use these forms to ensure the INCITS Secretariat has the latest membership information. These forms should be mailed directly to the INCITS Secretariat.

As is customary, the people attending introduced themselves. Attendance (see enclosure 1) was taken electronically via the meeting web site.

### 2. Approval of Agenda

No additions/changes were made to the draft agenda.

John Lohmeyer moved and Ralph Weber seconded that the agenda be approved. In the absence of any objections, the motion passed unanimously.

The following items were added or modified in the agenda during the course of the meeting:

### 3. Attendance and Membership

The membership requirements were reviewed. INCITS rules permit one vote per organization. An individual from a new organization must attend two out of three consecutive plenary meetings. He/she may apply for voting membership the second meeting via a letter to the Chair of T10. The individual may begin voting at the beginning of his/her second meeting. People who continue to attend T10 meetings are expected to join T10 and to pay INCITS Service Fees.

To maintain membership, organizations must pay the INCITS Service Fee (\$1200 per year).

John briefly discussed possible changes in mailing policies. Complete pricing information for mailings is contained in the 2008 membership form (available at [http://www.t10.org/ftp/t10/mem\\_form.txt](http://www.t10.org/ftp/t10/mem_form.txt)).

There are also minimum attendance requirements to maintain voting membership on T10. If a member organization fails to attend two of the last three T10 meetings, they are warned that failing to attend the next T10 meeting would result in their membership being terminated.

The Chair said that since the last meeting EMC had acquired Iomega. The Iomega membership was dropped at their request.

The Chair said he had sent e-mails to 4 people from 3 organizations informing them that the organization's membership was in jeopardy due to non-attendance (see 08-304r0) and that their membership would be terminated if they did not attend this meeting. The following organizations were in attendance jeopardy:

General Dynamics  
Iomega Corp. (now part of EMC)  
STMicroelectronics, Inc.

All organizations in attendance jeopardy were present except:

General Dynamics  
STMicroelectronics, Inc.

The representatives of these organizations had their membership changed to Advisory (non-voting) status.

John called for requests to join the committee. No organizations joined at this meeting.

The T10 membership during the meeting was 33 organizations, down from the 35 member organizations extant at the time the meeting was convened. Enclosure (1) is the list of the people present at the meeting and enclosure (3) is the current T10 membership list.

John Lohmeyer reminded members that failure to vote on two out of the last three letter ballots also would result in membership jeopardy. Accelerated and personnel letter ballots are not included in letter ballot jeopardy calculations.

John Lohmeyer moved and Ralph Weber seconded that the minutes be approved as written. In the absence of any objections, the motion passed unanimously.

John Lohmeyer requested that all documents for the next mailing be uploaded to the T10 web site by 10:30 a.m. Mountain time on Thursday September 18, 2008. Documents received after this time may go into a subsequent mailing.

John reminded the committee of the requirements for document submission. Since T10 meets its document retention requirements by preparing mailings, documents included in the mailing must be suitable for archiving. This means that Portable Document Format (PDF) and/or native-format electronic originals with proper identification must be submitted.

People can obtain T10 document numbers for new and revised T10 documents by filling out a web form at <http://www.t10.org/members/>. The assigned T10 document number will be sent to the requestor by e-mail. The requestor may then reply to this e-mail, including the document to be posted as an attachment. The document will be automatically posted on the T10 web site.

T10 members can complete this entire process using their personal T10 password. John explained that members who do not know their password should surf to the above URL and click on the "forgot password" link to have their password sent to them via e-mail.

John noted that non-members can also use the above document number process, but their requests will require approval by an administrator.

John Lohmeyer explained that this is a regular agenda item to identify any potential patent issues with developing standards and technical reports.

Questions about this policy are to be referred to the participant's legal counsel or the ANSI General Counsel. The Chair showed the "three slides" from the INCITS pat\_slides.pdf. No interpretation or explanation of the ISO/IEC/ITU patent policy was provided.

The Chair issued a call for patents.

Mark Seidel reminded the committee that a statement of the Intel patent policy can be found in T10/01-041r0.

John noted that he had received a licensing statement (08-333r0) from HP Development Company LLC regarding documents 07-361r6 and 08-029r2, which were incorporated into SSC-3 and ADC-3 respectively.

There were no responses to the call for patents other than those mentioned above.

## 8. Project Status Reports

### 8.1 Project Status Summary and INCITS Liaison [Lohmeyer]

John Lohmeyer said that the current T10 project status summary was included on the meeting web site and will be included in the mailing as usual.

#### 8.1.1 INCITS Antitrust Guidelines

All T10 members should be aware of the INCITS antitrust guidelines available at <http://www.incits.org/inatrust.htm>.

John reminded committee members that all persons present at a T10 meeting are responsible for identifying potential violations of the antitrust guidelines and reporting them to the Chair. Discussions of the following topics are considered sensitive:

- Any company's prices or pricing policies;
- Specific R&D, sales and marketing plans;
- Any company's confidential product, product development or production strategies;
- Whether certain suppliers or customers will be served;
- Prices paid to input sources; or
- Complaints about individual firms or other actions that might tend to hinder a competitor in any market.

### 8.2 Bridge Controller Commands (BCC) Project 1528-D [Elliott]

John Lohmeyer announced that INCITS had closed project 1528-D as T10 requested at the July 2008 meeting. He thanked Rob Elliott for the work he had done on this project.

**8.3 SCSI Enclosure Services - 2 (SES-2) Project 1559-D [Elliott]**

John Lohmeyer reported that the SES-2 public review period ended 14 July 2008. No comments were received. SES-2 is now at INCITS management review.

**8.4 SCSI Stream Commands - 3 (SSC-3) Project 1611-D [Peterson]**

Dave Peterson reported on the activities of the SSC-3 working group (minutes in 08-368). Dave also provided an electronic report in 08-378r0.

**8.5 SCSI Architecture Model - 4 (SAM-4) Project 1683-D [Penokie]**

John Lohmeyer reported that the SAM-4 public review period ended 14 July 08. No comments were received. SAM-4 is now at INCITS management review.

**8.6 Object-Based Storage Devices - 2 (OSD-2) Project 1729-D [Weber]**

John Lohmeyer reported that the OSD-2 forwarding letter ballot passed 29:3:4:0=36 with comments received from 8 organizations.

Ralph Weber reported that the SNIA OSD TWG will review an initial draft of the letter ballot comments resolution document next week and CAP will review the resolutions in November. He stated that the letter ballot comments resolution document has not yet been posted.

**8.7 SCSI Media Changer Command Set - 3 (SMC-3) Project 1730-D [Ballard]**

Curtis Ballard reported on the activities of the SMC-3 working group (minutes in 08-334, 08-335, and 08-376), and provided an electronic report in 08-376r0. He noted that the group is considering closing new technical input in January.

**8.8 SCSI Primary Commands - 4 (SPC-4) Project 1731-D [Weber]**

Ralph Weber reported that SPC-4 r16 was prepared after the last mailing and will appear in this mailing. Since no proposals have been recommended for inclusion in SPC-4 this week, no new revision will be generated before November.

**8.9 Automation/Drive Interface - Transport Protocol - 2 (ADT-2) Project 1742-D [Suhler]**

Paul Suhler reported on the activities of the ADI working group (minutes in 08-329 and 08-372). Paul provided an electronic report in 08-369.

**8.10 Serial Attached SCSI - 2 (SAS-2) Project 1760-D [Elliott]**

Rob Elliott reported that SAS-2 is at revision14d. A new revision, r14e will be posted with in the next ten days. Rob stated his belief that forwarding to public review should occur at the November meeting.

**8.11 SCSI Block Commands - 3 (SBC-3) Project 1799-D [Evans]**

Mark Evans reported that SBC-3 r16 was prepared since the last meeting and will be included in the next mailing. He noted that only one proposal has been recommended for inclusion in SBC-3 this week and that proposal only defines an informative annex. Mark hinted that he might not prepare a new revision before November.

**8.12 SCSI / ATA Translation - 2 (SAT-2) Project 1826-D [Overby]**

John Lohmeyer reported that the SAT-2 forwarding letter ballot passed 26:5:5:0=36 with comments received from 7 organizations.

Mark Overby reported that a SAT-2 working group meeting was held September 9 in Colorado Springs, CO (minutes in 08-353) and letter comment resolution was the primary topic of the meeting.

Mark noted that the next revision of SAT-2 will not be published until after the October 20 meeting co-located with T13.

### **8.13 Fibre Channel Protocol - 4 (FCP-4) Project 1828-D [Peterson]**

Dave Peterson led a discussion of the activities of the FCP-4 working group (minutes in 08-373). Dave provided an electronic report in 08-379r0.

On behalf of the working group, Dave requested that a letter ballot be conducted on forwarding FCP-4 r01 to public review.

John Lohmeyer took an action item to conduct a letter ballot on forwarding FCP-4 r01.

### **8.14 MultiMedia Command Set - 6 (MMC-6) Project 1836-D [McFerrin]**

In the absence of Bill McFerrin, John Lohmeyer summarized the activities of MMC-6 working group (minutes in 08-375). He noted the group continues to work through several significant MMC-6 issues.

### **8.15 Automation/Drive Interface - Commands - 3 (ADC-3) Project 1895-D [Suhler]**

Paul Suhler reported on the activities of the ADI working group (minutes in 08-329 and 08-372). Paul provided an electronic report in 08-369.

### **8.16 USB Attached SCSI (UAS) Project 2095-D [Stevens]**

Curtis Stevens reported on the CAP working group activities related to UAS (minutes in 08-354).

### **8.17 SCSI Architecture Model - 5 (SAM-5) Project 2104-D [Penokie]**

George Penokie reported that no SAM-5 activities have taken place yet.

### **8.18 SCSI Stream Commands - 4 (SSC-4) Project 2123-D [Peterson]**

Dave Peterson reported that no SSC-4 activities have taken place yet.

### **8.19 SAS Protocol Layer (SPL) Project 2124-D [Penokie]**

George Penokie reported that no SPL activities have taken place yet. He stated a goal of preparing a strawman outline for discussion at the next meeting.

### **8.20 Serial Attached SCSI - 2.1 (SAS-2.1) Project 2125-D [Cox]**

Alvin Cox reported that preliminary active cable work has been undertaken toward development of SAS-2.1.

### **8.21 SCSI / ATA Translation - 3 (SAT-3) Project 2126-D [Overby]**

Mark Overby reported that no SAT-3 activities have taken place yet.

### **11.1 Project Proposal for OSD-3 (08-331) [Weber]**

John Lohmeyer reviewed the OSD-3 Project Proposal, and noted that the CAP working group recommended it unanimously. A typo was noted in the Existing Standards reference to SPC-3, and Ralph agreed to prepare a new revision.

Ralph Weber moved that 08-331r1 (r0 as revised) be forwarded to INCITS as a project proposal for OSD-3. Mark Overby seconded the motion. The motion passed on a vote of 22:0:1:10=33.

Ralph Weber took an action item to prepare 08-331r1.

John Lohmeyer took an action item to forward 08-331r1 to INCITS as a project proposal for OSD-3.

### **11.2 Notification to INCITS T10 for 2009 National Standards Maintenance Recommendation (08-326) [Patrick]**

John Lohmeyer reviewed the standards on which 2009 review recommendations were requested by INCITS.

George Penokie moved that T10 recommend to INCITS that the following published standards be reaffirmed: SCSI-2, OSD, SMC-2, and SBP-3. Mark Evans, Kevin Butt, and David Black seconded the motion. The motion passed on a vote of 24:0:1:8=33 satisfying the two-thirds voting rules.

John Lohmeyer took an action item to notify INCITS that T10 recommends the reaffirmation of SCSI-2, OSD, SMC-2, and SBP-3.

The SAS Protocol working group made no recommendations to the committee this month.

Gerry Houlder moved that 08-192r1 be approved for inclusion in SBC-3. John Geldman seconded the motion. The motion passed on a vote of 12:2:10:11=33.

David Black reviewed 08-365r2 (Enhanced Discovery bit in PRLI) [Smith, Black] a proposal recommended for inclusion in FCP-4.

David Black moved that 08-365r2 be approved for inclusion in FCP-4. Gerry Houlder seconded the motion. The motion passed on a vote of 12:0:14:7=33.
