1. Opening Remarks

#### 4. SMC Topics

No SMC topics were discussed at the meeting.

After approval of comment resolution at the T10 September plenary, SMC has been forwarded to ANSI for further processing.

#### 5. SSC Topics

##### 5.1 SSC comment resolution. (97-204r1)

Gary Stevens provided his Proposed Resolution of T10 Letter Ballots on SSC along with revision 11 of SSC.

George Penokie reminded the group about the conflict between the Data Compression Page and the Select Data Compression Algorithm field in the Device Configuration Page. Gary will add language specifying that the Select Data Compression Algorithm field is ignored when the Data Compression Page is present.

A long discussion was held on the interaction between the Format Unit command and Mode Select. Gary will add language specifying that a Unit Attention will occur after a Format Unit command.

Gary will make a few other editorial changes to SSC as suggested by the group and prepare revision 12 of SSC to forward to NCITS for further processing.

The working group unanimously recommended that revision 12 of SSC be approved by the T10 Plenary as resolving the SSC letter ballot comments.

#### 6. Other Topics

No other topics were discussed.

#### 7. Meeting Schedule

No SSC/SMC meetings are scheduled at this time. If needed, SSC/SMC issues will be discussed during the regular SCSI working group meetings.
