If the Technical Committee action is to accept in whole or in part a proposal contained in the comment, then the changes should be sent to the Coordinator of Standards Processing together with any TC comments supporting the change. If the TC action is to reject in whole or in part proposals contained in the comment, the response should provide the rationale for the rejection.

The comment should be discussed at the next TC meeting, and if not definitively responded to at once, an interim acknowledgement should be sent along with an estimated date of action. When a final response is issued you must inform the commentors of their need to notify the Secretariat of their satisfaction or dissatisfaction with the committee's response. The commentor is required to send the Secretariat a written statement indicating acceptance or rejection of the TC response within fifteen working days. The commentor must be made aware that failure to respond within fifteen working days indicates to the Secretariat that the comment has been withdrawn.

This letter documents some recommendations for changes in document X3T9.2/86-109 (SCSI-2 proposed draft) which is currently out for Public Review.

Table 7-41 on pp. 7-52-56 should be preceded by a comment indicating the fact that Table I-1 contains the same information in numeric order. Similarly, Table I-1 on pp. I-1-6 should be preceded by a comment indicating the fact that Table 7-41 contains the same information in alphabetic order. Adding these comments could save some readers lots of time.

In addition, Tables 7-41 and I-1 should include "Suggested Related Sense Keys" as was done in the CCS Rev. 4.B document.

Table I-2 on pp. I-7-10 should be followed by a new table that lists the same information in alphabetic order. As I mentioned in a letter to you dated 12 January 1990, Table I-2 should also include the section number describing each command. Needless to say, this section number should also be included in this new alphabetically-ordered table.

I feel that the operation code information included in a thusly revised Table I-2 and newly created alphabetical table would make this document much easier for anyone to reference, first time user or otherwise.
